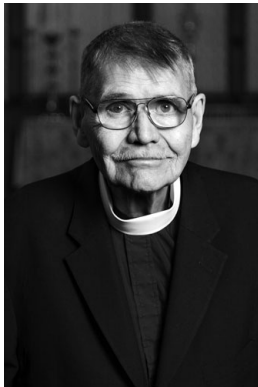

The reason why I went to seminary and sought ordination to the priesthood was because I observed that small churches could not afford a full-time priest. These churches were not able to have the sacraments regularly. In the Diocese where I served as a deacon, deacons were prohibited from presiding at pre-sanctified Holy Communion services.

The reason I am running for a seat on the Commission on Ministry (COM) is because our Diocese is faced with a shortage of priests to serve smaller churches. The traditional model of attending seminary for three or four years to obtain a MDiv is not practical. It costs about \$90,000 to \$100,000 to attend seminary. We have shepherded people through the ordination process and insured they meet the requirements for ordination.

Active participation in lay ministry in the Church has been the common thread in my life, integrating my commitments to God, my family, profession as an educator and community service. Although baptized in the Methodist Church of my grandparents in Johnstown, PA, I was confirmed in Glenshaw Valley Presbyterian Church after my parents moved to Pittsburgh. While serving as a VISTA Volunteer in community development in distressed neighborhoods in Detroit MI in the 1960s, I had a spiritual renewal influenced by my roommate, a former seminarian whose deep faith was exemplified by his Christ-centered behavior. I would like the Episcopal Diocese of Pittsburgh to consider my nomination for General Convention Clergy Deputy. I am currently the Priest-in-charge of St. James' Episcopal Church of Penn Hills where I have served as church planter for six years building a worshipping community. Thus far we have grown from zero to fifty worshippers with an average Sunday attendance of roughly 20 -25. During these six years we have baptized over twenty children and adults. St. James is also engaged in a more expansive vision as we develop a Family Resource Wellness Center, located at the church and focused on youth ages 8 to 21 and their families.

I have previously served as Parish Administrator, Executive Director and Assistant to the priest at St. Stephen's in Wilkinsburg. I have also developed and taught an evangelism class for the Episcopal Church Foundation as an ECF Fellow and have served as chaplain for the ECF Board retreat. Additionally, I have developed and taught classes at the Metro Urban Institute of the Pittsburgh Theological Seminary for their Church Leadership Certificate program.
