- Living into the 2018 Agreement with 9 ACNA parishes. In 2019-20, we began the informal visits with the ACNA parishes pursuant to the Agreement, and a number of us participated in those successful meetings.
- Continuing to develop a closer relationship with the Commission on Ministry, to help both bodies to better fulfill their canonical responsibilities in the formation of new ordained clergy. We held a successful evening-long meeting with the Commission and several candidates in February as part of this process.
- Working with our Chancellor on the development of a Regional Disciplinary Board that will combine resources in this area with our neighboring Dioceses of Northwestern Pennsylvania, Western New York, Ohio, Southern Ohio and West Virginia.
- Enthusiastically supporting our Bishop and our newly-appointed Canon the Rev. Eric McIntosh as they begin work on the Beloved Community initiative.

This is my last year on the Standing Committee, and I will always be grateful for this opportunity to serve our Diocese. My heartfelt thanks go to former members Darrell Powell and the Rev. Leslie Reimer, current members Lisa Brown, Bob Johnston, Steve Stagnitta, the Rev. Noah Evans, the Rev. Jonathon Jensen, the Rev. Eric McIntosh, the Rev.
