Special Convention Information

Pre-Convention Information Session: There will be a pre-convention information session on Thursday, December 4 at 7:30 p.m. at Calvary Episcopal Church in East Liberty, 315 Shady Avenue at Walnut Street, Pittsburgh. All deputies and clergy are encouraged to attend.

Convention Location: All events on Friday, Dec. 12 and Saturday, Dec. 13 will be held at St. Paul's, Mt. Lebanon, 1066 Washington Rd., Mt. Lebanon. (412-531-7153)

Banners: Congregations are encouraged and invited to bring their parish banners (and its stand) to the convention. If you don't have a parish banner, consider having your youth make one for you. The banners will be on display in the convention meeting room. Then you are invited to have a member of your parish carry the banner in the procession for the concluding Eucharist. To take part, check the box for banner participation on the participation form.

Choir: Choir members from all parishes are invited to participate in the choir for the Eucharist. Contact Choirmaster and Organist Doug Starr at St. Paul's for more information at email: dstarr@stpaulspgh.org or phone: 412-531-7153, ex. 16

Food: Deputies, clergy, and general participants are all welcome to register for the convention. There is a reception on Friday night following Evening Prayer. This is an opportunity for everyone to meet those providing leadership to the diocese in this time of transition and to meet the special invited guests. On Saturday, there will be coffee and continental breakfast items at registration, a mid morning break with food, and a reception following the Eucharist and ordination. We ask registrants to contribute \$10 towards food costs.

Hotel: The Crowne Plaza Pittsburgh South at 164 Fort Couch Rd has a block of rooms held for those attending convention at a special church rate of \$99 for a king or double queen room. The hotel is 2 miles from St. Paul's. We will have some form of shuttle for those staying at the hotel who do not have cars. The number for the hotel is (412) 833-5300. Be sure to state that you are a part of the Episcopal Diocese of Pittsburgh and using the St. Paul's special rate and that the reservation must be done by the local hotel not the central reservations center. To get this special rate, reserve your room by December 1.

Displays: There will be a modest amount of space in the registration area for displays. Groups listed in the back of the diocesan directory issued in September, 2008, appear on The Episcopal Church web pages as a church-related group or organization, or who participated in Across the Aisle are welcome to request space. Special Guests: The diocese has invited a number of special guests. Among those expected to attend are leaders of Province III, Bishop David Jones, several of the Bishops of surrounding dioceses, and leaders from ecumenical organizations and churches, and from seminaries in the Pittsburgh area.

Ordination: The closing Eucharist will include an ordination. Clergy are invited to vest and participate in the service. The color for stoles is red.

Childcare: St. Paul's is making available child care for infants and children up to age 7 at no cost on Saturday, December 13. It is available for both the convention and the concluding Eucharist. There is a place on the participation form to indicate your interest.

Accessibility: St. Paul's has an elevator system that serves all spaces used for the convention and worship.

Driving Directions to Calvary Episcopal, corner of Walnut and Shady in East Liberty:
From Route 8: West on Fifth (towards downtown) and then turning North (right) on Shady Ave.

From 376 (parkway East) Take the Swissvale exit and head towards Regent Square on Braddock. Turn left on Forbes and then turn right at the third light (Shady).

From Route 28, take the Highland Park Bridge exit towards Washington. Merge on to Butler. At first light, turn right and follow Route 8 (Blue Belt) south to Fifth Street. Turn Right (west) on Fifth. Turn right on Shady (2nd light).

Driving Directions to St. Paul's Mt. Lebanon, 1066 Washington Rd.:

St. Paul's is located two blocks south of the intersection of Cochran Rd (Rte. 19) and Washington Rd (Truck Rte. 19).

Those coming from the North can access Rte. 19 from 279. Truck 19 is accessed from the Liberty Bridge and Tunnels. For those coming from the East or South, Rte. 51 intersects with Rte. 88 (west/south). Take 88 to the V intersection where Castle Shannon goes west and Rte. 88 goes south. This is a very sharp intersection for those coming from the south on 88. Take the Castle Shannon fork (west/north). Turn left on Mount Lebanon Rd which intersects with Washington (19). Turn right (north) on Washington.

Parking: Parking will be available at St. Paul's and at the Christian Science Church 1/2 block away.

RESOLUTION ONE
Waiver of Advance Notice Requirements

WHEREAS, the process of determining the number of vacancies and recruiting nominees was especially complicated in this rebuilding period; and

WHEREAS, the nominations have been available to members of this convention in time for them to make further nominations from the floor; and

WHEREAS, all resolutions have been published and distributed to deputies and clergy before the convention;

THEREFORE BE IT RESOLVED, that the convention believes that the spirit of the requirements for advance notice in the Standing Rules of Order have been met and waives the specific deadlines for nominations and resolutions found in those Rules for Order.

RESOLUTION TWO
District Reorganization

WHEREAS, Canon XVIII, *Section 1*, provides that “The Diocese shall be divided into such Districts, not less than six nor more than ten, as may be determined from time to time by action of the Convention;” and

WHEREAS, the Diocese is currently divided into eight Districts numbered 1, 2, 3, 4, 5, 7, 8, and 10, respectively; and

WHEREAS, District 1 is geographically contiguous to District 2, and District 10 is geographically contiguous to District 5; and

WHEREAS, the current situation indicates that the number of Districts should be reduced to better fit the size and configuration of the Diocese;

THEREFORE BE IT RESOLVED, that the number of Districts be reduced to six by merging Districts 1 and 2 into a reconfigured District 2 and by merging Districts 5 and 10 into a reconfigured District 5.

RESOLUTION THREE

Affirmation of Standing Committee Actions

RESOLVED, that the actions and appointments made following the October 4, 2008 Annual Convention by the Standing Committee of the Episcopal Diocese of Pittsburgh of the Episcopal Church, as the remaining ecclesiastical authority, were necessary and in order to move the diocese forward after the departure of many diocesan leaders. Therefore this convention affirms those actions and appointments.

Revised Resolution IV

Whereas, purported amendments since November 2003 to Article I and Article XIII of the diocesan constitution were in conflict with the Constitution and Canons of The Episcopal Church.

Whereas Article V of the Constitution of The Episcopal Church requires an unqualified accession from each diocese to the constitution and canons of The Episcopal Church and outlines the conditions by which one diocese may transfer property to another, and

Whereas, action to implement the purported constitutional amendments was taken on October 4, 2008, adopting a canon to purportedly remove the Diocese from the Episcopal Church and realign the Diocese with another province of the Anglican Communion, and

Whereas, the convention wishes to affirm that the Diocese considers all such actions purporting to modify or remove the accession clause, realign the Diocese with another province of the Anglican Communion, or facilitate direct admission of parishes located physically in other dioceses to be null and void and of no effect, therefore be it

Resolved, that all such actions taken since November 2003 purporting to remove the accession clause from the Diocesan Constitution, unilaterally change the bounds of the diocese or to remove the Diocese from the Episcopal Church and realign it with another province of the Anglican Communion are null and void and of no effect, and be it further

Resolved, that the Committee on Canons is charged with the duty to prepare a report to be completed prior to the next annual meeting of Diocesan Convention that includes their findings regarding the operative language of the Diocesan Constitution and Canons along with any recommended actions to modify or amend the same.

Coming Together in Faith Nominations

Because there are an extraordinary number of vacancies to be filled at the Special Convention, the search for people willing to fill these spots is taking longer than usual. The nomination deadline is December 1, 2008.

Information on the nominees will be mailed to all deputies and clergy on December 3, 2008. If you wish to add a candidate, after circulation of the original list of nominees, this can be done by submission of an application to the nomination committee before December 11, 2008. These additional nominations require the signed support of at least 10 members of the convention. Any nominations submitted by December 11, 2008 shall appear on the ballot.

With the signed support of 10 members of the convention, additional nominations made be made on the day of the convention. These nominations will be announced by the Nominating Committee as part of their report.
